RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT

(hereinafter the "Release Agreement")
BY SIGNING THIS RELEASE AGREEMENT YOU WILL WAIVE OR GIVE UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE OR CLAIM COMPENSATION FOLLOWING AN ACCIDENT

PLEASE READ CAREFULLY!

TO: **3AM GROUP INC.**, (operating as WILDERNESS EQUIPMENT RENTALS, RENT-A-TENT CANADA, RENT-A-TENT BANFF) **His Majesty the King** in the Right of the Province of Alberta (and **Parks Canada**), and their directors, officers, employees, instructors, guides, agents, independent contractors, subcontractors, representatives, successors and assigns, (all of whom are hereinafter collectively referred to as "THE RELEASEES").

CAMP / TREK - Equipment Care Agreement

- I understand that I cannot wear shoes inside my tent or slide hard items (such as hard-sided suitcases) across the floor. This WILL put holes in the floor of the tent.
- o I understand that the tarp/groundsheet/footprint I am given is meant for underneath my tent to protect it from rocks and other debris and I agree to use it as instructed. Failure to do so may lead to damage of the tent or water leakage.
- o I understand that I must not pack sharp items together with the tent, such as: rock proof tent pegs, hammer and hatchet.
- o I understand that I have to set up my tent at a safe distance (at least 5 meters) from the campfire to prevent embers from burning holes in the tent. I agree to keep open flames and sources of ignition away from my tent, including but not limited to lighters, matches, cigarettes or e-cigarettes, and heaters.
- I understand that I cannot use my pots and pans on an open fire. This burns the pots and makes them unusable and they will need to be replaced.
- I understand that tent poles can be bent, or broken <u>easily</u> if the tent is raised forcefully from one side. Please always raise the
 tent with two people and with extra care (not too much force).
- I understand that I NEED to return all equipment as clean as when I received it (bottoms of tents excluded). If I don't do this I will pay a cleaning fee of \$75 CAD per booking.
- I understand that when it is raining I will need to avoid touching wet tent walls, both with my body and my gear. If the interior wall of the tent contacts the exterior wall of the rain fly, even for just a moment, moisture can seep into the tent.

In the case of **pre-existing problems** with the equipment, renters must contact the Releasees as soon as possible. Renters may then purchase replacement goods and are required to keep the malfunctioning gear and the receipt of the purchase to obtain a refund. Rent-a-tent Banff will reimburse renters for replacement of the malfunctioning camping gear to a maximum amount of \$500 CAD per booking.

All rental equipment needs to be returned in a **non-damaged, cleaned state,** including all parts.

If a rental is not **returned before 6:00 pm** on the end date of a reservation; The Releasees reserve the right to charge a late fee of \$80 OR 25% of the booking's total, whichever is greater, PER CALENDAR DAY. There are no credits or refunds for early returns of the rental equipment.

Renters are responsible for the proper use and care of the equipment. The Releasees are not responsible for any losses, damage, or additional expenses incurred by the guest for any reason including but not limited to faulty equipment; improper setup, use, or storage; or extreme weather conditions.

Assumption of Risks

I am aware that camping, and using rental camping equipment involves risks, dangers and hazards and that injuries can result from improper use, insufficient skill, or campsite selection.

CAMP STOVE- I understand that the camp stove uses propane fuel to produce a contained flame. If the stove is improperly set up, or has been damaged, a malfunction could result in an out of control flame, or gas leak, which can result in bodily harm or death.

TENT- I understand that a tent malfunction due to improper setup/installation, (pre-existing) damage can cause a tent to collapse. This can result in bodily harm or death.

SHARP RENTAL ITEMS- I understand that all sharp rental items such as cutlery, axes and hatchets, and all other cooking utensils contained in the rental package can be potentially dangerous. Misuse and/or improper use can result in bodily harm or death.

CHILDREN- I understand that children should not be left unattended with any rental package item, especially the above-mentioned items. Injuries can easily occur with: sharps, flammable items and heavy objects.
